Submitting the application

Pyrotechnic activities for civilian use that require a licence (use, distribution and storage, distribution, storage, display, destruction, inspection, export to a non-EEA state, import from a non-EEA state) shall be authorised by a decision of the authority.

Within 15 days of the communication of the decision, the customer may appeal against the decision in the first instance or waive his appeal rights. Activities authorised in decisions that an appeal has been brought against may not be pursued. The waiver of appeal may not be withdrawn. In the case of a waiver of appeal, or a withdrawal of an appeal, the decision shall become effective on the day of the receipt of the waiver or withdrawal by the authority.

The waiver has to be submitted to the county (or Budapest) police headquarters making the decision at first instance.

Processing the statement

The authorising authority shall examine the waiver (eligibility, deadline), and in justified cases shall order the customer to supply missing items. The customer can supply the missing items requested using the RHIP-001 ANYK form.

If the authority accepts the waiver, it shall notify the customer of the decision becoming final. Notifications or decisions concerning the waiver shall be communicated to the customer electronically.
