#### Procedure

Natural persons who have reached the age of 18, have legal capacity; have no criminal record, and no court has established their criminal liability for committing crimes specified in the Arms

Act, furthermore, who are not subject to criminal proceedings on reasonable suspicion of a crime listed in the Arms Act, may be authorised to hold firearms capable of discharging projectiles with an energy not exceeding 7.5 joules (Flobert guns) exclusively.

### **Submitting the application**

Applications for a licence to possess a firearm for target shooting (Flobert gun) are to be submitted to the police headquarters whose jurisdiction covers the applicant's place of residence; in Budapest, to the Budapest Police Headquarters.

### **Costs and expenses of the procedure**

The amount of the administrative service fee is HUF 2,000, which is to be paid into the appropriation allocation fund account of the county police headquarters governing the local police headquarters proceeding at first instance; in Budapest, the Budapest Police Headquarters. The payment is to be made at the latest on the day after knowledge of the registration number of the authority in charge of the case.

The reason for the payment – "application for a licence to possess a firearm for target shooting (Flobert gun)" and the registration number of the case is to be indicated in the reference field. (Registration number: the "RZSEIR" registration number indicated on the notification sent by the document management system of the Police to the applicant's Client Gateway storage space).

The account numbers are included in Attachment 2 of the D.

No attachment needs to be added for the approval of the application.

### **Processing the application**

If the applicant has submitted a fully completed application to the relevant and competent authority, or if necessary, has complied with the authority's request for supplying missing items, and there are no circumstances concerning the applicant that – according to the Arms Act – rule out the authorisation, the authority shall authorise the possession of the firearm (Flobert gun) for target shooting. The authorised person may collect the licence for possessing firearms in person, and after purchasing the firearm he is obliged to appear before the authorising authority, with the firearm and the technical certificate of the firearm, within the deadline specified in the G.d. The authority shall issue a licence card, which the applicant may collect in person at the authorising authority, during opening hours.

The opening hours are shown on the official web site of the Police.
