## **Procedure**

Theatrical weapon may be licensed to theatres, business organizations engaging in stage performances or filming, to filmmakers or traditionalist if the firearms comply with technical requirements set out in G.d. 22. appendix.

A licence to possess firearms with a muzzle energy not exceeding 7.5 joules (Flobert firearms) can be granted to natural persons and to the organisations and associations listed below.

- a sports association registered for the purpose of sport shooting if the national sports association confirms the membership of the requesting sports association,
- an organisation having a permit to operate a shooting range for the purpose of sports or education, as well as for firearms of the specified type and calibre, furthermore, it has shooting range safety rules and regulations, or has a lease contract for the premises of such a shooting range,
- an organisation authorised to inspect firearms, ammunition and deactivated firearms for civilian purposes, or authorised to deactivate firearms and ammunition,
- an organisation having a licence to manufacture ammunition,
- an organisation whose scope of activities includes the protection of its own or others' assets, and the protection of life and physical integrity of other persons, furthermore
- an organisation whose scope of activities includes shooting training.

## **Submitting the application**

Application for requesting a licence to possess theatrical firearms or firearms for target practice (Flobert firearm) must be submitted to the relevant police department of the place of activity of the organisation; in Budapest, the Budapest Police Headquarters.

## **Costs and expenses of the procedure**

The administrative service fee payable for the application for the licence to possess theatre firearm or Flobert firearms shall be HUF 2,000 for each weapon. An additional HUF 2,000 of service fee for authorising each employee as a person liable for handling and storing the theatrical weapons.

The administrative service fee is payable in advance or ex-prior to the appropriate allocation bank account held by the relevant county police department in charge of the police department initially involved; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. „ Application for requesting a licence for associations to possess a theater weapon and to keep a firearm with a pendulum energy of 7.5 joules or less for target practice (exchange, replacement)” and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

### **Attachments to be added to the application submitted in pdf files**

For applications regarding Flobert firearms:

- in the case of sport associations: confirmation of the membership by the national sports association;
- in the case of organisations having a permit to operate a shooting range for sports : the permit to operate the shooting range or the lease contract for the premises of the shooting range;
- in the case of organisations authorised to inspect firearms, ammunition, or authorised to deactivate firearms: the official document verifying the activities;
- in the case of organisations having a licence to manufacture ammunition: the manufacturing licence;
- in the case of organisations carrying out private security activities: the permit issued by the police authority.

The organisation submitting its application must present the original copy/copies of the attached documents, if required by the authority.

An attachment to the application shall not be required in connection with the replacement of a permit for the possession of a theatrical weapon and for the replacement or replacement of a permit for the possession of a Flobert firearm (card document).

### **Processing the application**

If during processing the application it is established that the entitled applicant has submitted the complete application to the authority having appropriate jurisdiction, or the applicant has complied with the request for correction or amendment, and the application meets the legal regulations, the authority shall make a decision of granting a licence to possess firearms (licence). The licence and card document can be collected by the licence holder in person or via their authorised trade representative, then upon the purchase of the firearm(s), and within the deadline set forth in G. d., the licence holder must appear at the licensing authority together with his/her firearm(s) and their technical approval(s).
