I. Introduction

- 1. The organization established to carry out general law enforcement tasks (hereinafter referred to as the Police) ensures the rights of Customers stipulated in Act CCXXII of 2015 on the General Rules and Regulations for Electronic Administration and Trust Services (hereinafter referred to as Act) and in accordance with its implementation regulations via an information system providing electronic administration.
- 2. The Rules and Regulations of service of the Police on electronic administration by the provision of electronic forms (hereinafter referred to as Rules and Regulations) is publicly available on the official website of the Police.

II. The scope of the Rules and Regulations

- 3. The personal scope of the Rules and Regulations shall be extended to the police authority providing electronic administration, and the customer entering into a relation with the authority when using the electronic forms.
- 4. The Rules and Regulations contain the general provisions related to the use of electronic forms during electronic administration, as well as the rights and liabilities between the Police and the customers arising out of the use of forms.
- 5. Irrespective of their location, the Customer could use the electronic administration service from anywhere in the world via Internet connection.

III. General provisions

1. Definitions and acronyms

- 6. The terms used in the Rules and Regulations are used in the generic meaning of the words, with the exception of the definitions listed under this present heading, which definitions are considered to have the meanings as described below.
- 7. *Customer:* a natural or legal person or a person authorized to represent, using electronic administration provided by the Police under the terms as described in the Rules and Regulations.
- 8. *Party/Parties*: as regards the application of the Rules and Regulations, they are either exclusively the Client or the Police, separately or in combination.
- 9. *Down time:* the time-period during which the possibility of the use of electronic administration falling within the scope of the Rules and Regulations is not provided. Down time excludes the planned maintenance of the information system ensuring electronic administration.
- 10. Central Authentication Agent (KAÜ): a central electronic administration service (hereinafter referred to as: KEÜSZ), in the course of which the KEÜSZ service provider ensures the Police to allow the customer to freely choose their means of identification, and also ensures the implementation of the specific identification as required with the identification service provider selected by the individual to be identified.
- 11. General Form Filler framework program (ÁNYK): a form application support service that ensures that by using the available and downloadable application by KEÜSZ service provider, the planning of the electronic forms in conformity with the technical specifications as defined by the service provider can be planned, and the Customer can them fill in, and the authorized Customer can submit them.

- 12. *e-Papir*: a KEÜSZ service, in the course of which the service provider ensures that the Customer, upon being identified in accordance with paragraph 2 of section 18 of Act, can submit to the Police a free text application, if the legislation does not prevent the application being submitted in an electronic format, nor does the legislation establish any further formalism regarding the application being submitted in an electronic format.
- 13. *inNOVA Portal (Portal)*: an e-administration interface provided by the Police, which offers the Customers and the users opportunities to fill in forms, submit applications, and follow up the processing status of applications online.
- 14. *inNOVA form*: a form that can be submitted via the online interface available on the Portal interface.
- 15. Secure Delivery Service (BKSZ): a KEÜSZ service that, regarding the delivery of the electronic message, ensures as follows:
 - a) the confirmation of the delivery of the message if the delivery system has received the message from the sender,
 - b) the integrity of the messages,
 - c) the authentication of the recipient (the recipient of the message can only be the addressed person or the authorized substitute recipient),
 - d) the confirmation of failed delivery.
- 16. *Disposition Register (RNY)*: a system that registers the customers' directions/orders/provisions as regards their electronic administration (including those related to contact and communication, as well as the legal acts on representation), and enables the entitled persons for query and search.
- 17. *Identification-Based Document Authentication (AVDH):* a KEÜSZ service, in the course of which the service provider specified in the legislation assigns to the person authenticated by the service provider the declaration provided by the customer, then it credibly confirms the assignment to the person. By the help of AVDH, citizens not having a qualified electronic signature can also authenticate documents, thus they can fully participate in electronic administration.
- 18. *Malfunction*: the temporary or permanent failure or breakdown of the information system used by the Police as the tool for electronic administration, as a result of which the information systems are unable to properly ensure electronic communications and administration.
- 19. *NOVA.PACK service:* Provides the production of electronic forms systematized by the Police in an encrypted KRX container for those communicating via a machine interface.
- 20. Machine interface: system-to-system interface supported by authorization management.

2. Data of the organization providing electronic administration

21. The data of the police bodies providing the electronic administration of each type of case can be found on the official website of the Police, available at http://www.police.hu, in the menu item Administration / Organizational units.

3. Contact information of customer service in relation to electronic administration

- 23. As regards queries requiring special expertise, the specialty experts at the National Police Headquarters provide Level 1 customer service specialist support (hereinafter referred to as: Level 2 customer service), which support is available during the business hours of the Police.
- 24. Official business hours: from Mondays to Thursdays: 0730-1600 hours; on Fridays: 0730-1330 hours.

4. Audio recording of telephone calls between customer service and Customer

- 25. An audio recording is made on the telephone communication between Customer and Level 1, and Level 2 customer service. The audio recordings are kept by the Police for 5 years.
- 26. Upon Customer's request, the Police shall, within 30 days upon being informed of Customer's such request, provide free of charge the customer an opportunity to listen to the audio recording, and additionally, it shall provide a one-time electronic copy of the audio recording on each audio recording.

IV. Detailed provisions

- 27. In respect of the case groups published on the website, the Police, unless the legislation provides otherwise, shall ensure electronic administration in accordance with the official work schedule, whose exhaustive list at the times of the Rules and Regulations being published can be found in annex 1.
- 28. Concurrently with using the electronic administration, the Customer shall accept and agree to be bound by the provisions of the Rules and Regulations, and shall acknowledge that, upon accepting the Rules and Regulations and upon the use of the system, he/she shall have incumbent obligations related to the use of electronic administration without concluding an individual contract on such use.
- 29. The Police provides electronic administration in accordance with the provisions of Government Decree 451/2016. (XII. 19.) on the detailed Rules and Regulations of electronic administration (hereinafter referred to as: Vhr.) and in accordance with the content of the Act.
- 30. If the legislation stipulates that, as an annex to be attached, a certified copy, either an original one or a properly certified duplicate, must be submitted by the Customer to the electronic administration, the customer must attach a document certified in accordance with the stipulations of document authentication in accordance with the Rules and Regulations established by the Act and Vhr.
- 31. The Police considers authentication service providers issuing certificates acceptable to the Police those authentication service providers issuing certificates that are listed on the websites http://webpub-ext.nmhh.hu/esign/index.jsp, as well as https://ec.europa.eu/digital-single-market/en/eu-trusted-lists-trust-service-providers.
- 32. The customer maintains electronic communication with the Police by using the access points (client gateway, corporate gateway, government gateway) serving as access to securing electronic communication.
- 33. During communications in relation to electronic administration, the occurrence of the presumption of delivery shall be governed by the laws in force.

- If in a certain case group the electronic administration is not mandatory, the natural person Customer's administrative provision excluding electronic administration fully or in relation to any procedural step therein shall also exclude the occurrence of the presumption of delivery in relation to the electronic declaration, unless the law provides otherwise.
- 34. As regards cases, for which ÁNYK or inNOVA forms have been established (Annex 1), unless the legislations provides otherwise, submitting the application in e-Papír format is considered 'not submitted' by the Police. The customer will be informed within 8 days as regards the application being 'not submitted' and on the possible solutions of submitting the application.

5. The procedure of electronic administration

- 35. The electronic administration of case groups listed in Annex 1 shall be carried out using the electronic forms defined therein.
- 36. Submitting the electronic forms by electronic means to the police authorities specified in the electronic form shall be carried out using ÁNYK or Portal services or e-Papír service via the government gateway of the Police in accordance with the following:
 - a) the current electronic form (ÁNYK or inNOVA) is available via the website of the Police (https://ugyintezes.police.hu),
 - b) in order to fill in the ÁNYK form, it must be downloaded to the computer used by the Customer. The form e-Papír can be filled in directly on the central e-Papír service interface: https://epapir.gov.hu/ website. The form inNOVA can be filled in directly on the Portal;
 - c) the application supporting filling in the ÁNYK form can be downloaded from the website ÁNYK nyomtatványkitöltés,
 - d) the filled-in ÁNYK form and its annexes can be submitted via the ÁNYK form application support service, while the e-Papír form via the e-Papír service [in both cases the service provider is NISZ National Infocommunications Service Company Ltd. (hereinafter referred to as: NISZ Zrt.), contact information: www.nisz.hu], and the inNOVA form can be submitted by the Customer authenticated by the KAÜ application using the Porta to the repository of the Police
- 37. The completed electronic form and its annexes will be forwarded to the repository of the Police via BKSZ, the reception of which will automatically be confirmed by sending confirmation to Customer's secure electronic communications repository:
 - a) in case of ÁNYK forms directly from the government gateway of the Police. The content of the submitted ÁNYK will be available to Customer on his/her own terminal;
 - b) in case of e-Papír, NISZ Zrt. will send an automatic confirmation (confirmation of receipt and download) which confirms that the e-Papír has been successfully submitted to and it has been downloaded by NISZ Zrt. NISZ Zrt. will forward the e-Papír to the government portal of the addressee selected by the Customer. Being the intermediate organization, NISZ Zrt. is indicated as the addressee in the automatic confirmations. The e-Papír filled in by the Customer can be downloaded from the address displayed during submission, which address contains the addressee selected by the Customer;
 - c) in case of submitting the inNOVA forms directly from the government gateway of the Police. The electronic signature of the application is necessary to submit the inNOVA forms, and the Portal will use the AVDH service. The Portal forwards the authenticated application to the Customer's official repository, from where it will be forwarded to the official repository of the Police by using the BKSZ service. The Customer can monitor the status of the actual administration on the Portal.

- 38. The Police shall process the submitted electronic form for administration in a format, whose data content can directly be displayed by widespread office or browser programs for human readable interpretation, and which contains the data content of the form in a structured way suitable for automated processing.
- 39. If the annexes to the submitted electronic form cannot be identified (file format mismatch), the Customer will receive an automatic error message. The submitted electronic form will be processed, and the resubmission of the non-identifiable attached documents will be determined in accordance with the Rules and Regulations of administration.
- 40. Items sent to the official repository of the Police will be automatically be registered by the document management system of the Police and an automatic notification will then be sent to the Customer's official repository on the receipt of the electronic form, its date of receipt, and the receipt identifier, of which the Customer will be served notice via the official communication channels.
- 41. In case of ÁNYK forms or inNOVA forms, if the Customer does not submit his/her application on the current electronic form available on the website of the Police, but on an earlier repealed or invalid version, the Police will then send a notice on the refusal of admission via the official communication channel to the Customer's repository.
- 42. The administration is carried out in accordance with the laws in force, irrespective of the way of submission of the underlying application or request.
- 43. If the natural person submitting the electronic form acts for the Customer as his/her proxy, he/she has the obligation to attach his/her authorization to the application in accordance with the sectoral legislation, or record it in the Official Register.

6. Technical requirements, information

- 44. The definition of the documents to be attached to the individual forms, and their requirements are available in the information section of the individual forms on the Police administration portal.
- 45. The attachable file formats are specified in Annex 1 to Vhr., which formats can also be uploaded in the authenticated "asice" format. Additionally, the Police also accepts .doc and .xls file formats.
- 46. The parameters of the attachable files, in particular the resolution in cases of images or the sampling frequency in case of audio materials, must be selected in accordance with the intended use.
- 47. The relevant technical requirements in relation to the computer necessary to fill in the ÁNYK forms are contained the installation configuration of the ÁNYK form filler program (ÁNYK telepítési és kitöltési utasítás).
- 48. The technical conditions that can be used when filling in the inNOVA forms are contained in the inNOVA portal user manual.
- 49. Notifications and confirmations as regards electronic administration shall be stored for a limited time on Customer's repository in accordance with the service conditions of the service provider of the repository.
- 50. In case of e-Papír, the respective size limit regarding the attachments to be uploaded is available on the e-Papír website during completing the application.
- 51. In case of ÁNYK forms, the size limit of the attachment applicable to any and all attachments is 300 megabytes

52. Technical and administrative details of using the NOVA.PACK service are available in the KKSZB Service Catalog.

7. General obligation of cooperation

- 53. Upon using electronic administration, the Police and the Customer consent and accept that, in order to complete the tasks contained in the Rules and Regulations, they shall cooperate with particular attention, and on the basis of the applicable legislation. In the course of the above, the Parties undertake to work actively to avoid and prevent any and all behavior, circumstances or conditions which are contrary to these present Rules and Regulations or which may hinder or thwart the content therein.
- 54. During the use of electronic administration, the Police and the Customer must act in constructive interaction taking into account each other's interests.

8. Modification of the Rules and Regulations

55. The Police reserves its right to unilaterally modify the Rules and Regulations in accordance with the requirements resulting from the principle of good faith and fair dealing, and in accordance with the principle of proper exercise of rights. The Police shall publish the modification on its website and send it to EÜF at least 15 (fifteen) days prior to the modification entering into force

9. Availability

- 56. The availability of the use of the electronic administration of the Police shall be 7 days a week, and 24 hours a day, with the derogations set out in this chapter.
- 57. NISZ Zrt. is the operator of the e-Papír service. The availability of the e-Papír service is set out by the operator in the general terms and conditions (e-Papír ÁSZF) of the general purpose electronic request form (e-Papír).
- 58. The AVDH service, the KAÜ service and the BKSZ service are provided by NISZ Zrt. The availability of the services is set out by the general terms and conditions (<u>AVDH ÁSZF</u>; <u>KAÜ ÁSZF</u>; <u>BKSZ ÁSZF</u>).

10. Changes resulting from force majeure

- 59. Any and all fortuitous events that may temporarily prevent or restrict either Party or both Parties in respect of the fulfillment of the contract constitute a special situation. The events that constitute a special situation include, in particular, the malfunction or breakdown directly unavoidable by the Police in relation to the services set out in the Rules and Regulations, the shutdown of the support system for security reasons, the network failures, any and all technical errors falling outside the authority of the Police, or natural disasters preventing or restricting the operations of the services.
- 60. In case of extraordinary situations, the Police shall immediately take the necessary measures in order to provide the uninterrupted functioning of the electronic administration, and shall also immediately inform the public on the website of the Police on the extraordinary situation, and its effects caused in the availability of the electronic administration, as well as it shall communicate when the Police will be able to fulfill any and all obligations arising from the Rules and Regulations.

- 61. The events falling outside the authority of the Police are as follows:
 - *a*) any and all damages caused by force majeure, including in particular the damages caused by the shortfall of the SZEÜSZ and KEÜSZ services,
 - b) any and all damages caused by the shortfall of the services during the period of time of the announced suspension,
 - c) any and all damages caused by the Customer's failure to cooperate.

11. The suspension of the service, maintenance

- 62. The Police, subject to prior notification of the Customer, may suspend the electronic administration for the purpose of carrying out maintenance, renovation, software change and enhancement, or any related activities in its network (hereinafter referred to as: maintenance works).
- 63. On its website, the Police informs the Customer on the planned maintenance works and the date and time period set out for it at least five days prior to its commencement. The Police shall carry out the planned maintenance works so that they restrict the availability of the electronic administration to the least extent possible or not at all.
- 64. The necessary downtime periods during the planned maintenance works, if maintenance is carried out in the maintenance window, will not reduce the time of availability.

12. Reporting and complaint handling procedures

- 65. Reports or complaints in relation to the electronic administration regulated by the Rules and Regulations are subject to a limitation period of 6 months from the date on which the conditions leading to such circumstances occurred, and they can be done via e-mail sent to panasz.orfk@orfk.police.hu. This limitation period shall not affect the Customer's right, provided by procedural law concerning the electronically administered case, to exercise his/her right to appeal provided in relation to the administration, which is governed by the underlying procedural law.
- 66. Conducting an investigation in relation to a complaint has a deadline 30 days following the submission of the complaint.
- 67. The Customer may initiate supervisory examinations with EÜF in case of the infringement of his/her rights provided for in the Act, or in cases when the authority providing the electronic administration fails to comply with its obligation that may affect the Customer's rights or legitimate interests.

13. Data protection and confidentiality

- 68. The Parties undertake that, during the activities carried out in relation to the provision of services, they shall treat and keep as confidential any and all data, facts and pieces of information that one Party has become aware of, or has come into its possession in regard to the other Party to the contract, furthermore neither Party shall disclose such information to the public or unauthorized third parties without the other Party's prior written consent and approval. The management of data relevant to the matter serving as the basis of electronic administration shall be governed by the law relevant to the specific procedure.
- 69. As a data management authority falling within the scope of Act L of 2013 on Electronic Security of State and Local Government Organizations (hereinafter referred to as: Ibtv.), the Police shall provide for the confidentiality, integrity and availability of the data it manages in accordance with the provisions of Ibtv.

- 70. Confidentiality has been concluded between the Parties for an indefinite period.
- 71. If any of the Parties breaches its obligation of confidentiality, it shall then be held liable to pay the other Party for the cost of the resulting damage.
- 72. The following do not constitute the breach of data protection and confidentiality:
 - a) disclosing data, facts and pieces of information that are public, those whose being public is required by the law, or those that have already been made public by the consent and approval of the other Party,
 - b) forwarding or transmitting data, facts and pieces of information on the basis of the obligation of law, decision or court ruling by simultaneously informing the other Party,
 - c) forwarding or transmitting data, facts and pieces of information to authorities authorized to obtain information on the basis of the existence of statutory conditions and with a request to that effect,
 - *d*) fulfilling reporting and disclosure requirements and obligations as imposed by law on the Police or the customer.
- 73. The obligations specified herein are imposed on the proxies of the Customer and the Police identically with those of the Parties.

14. Data processing requirements

- 74. The personnel authorized to process personal data shall be the Police personnel with defined responsibilities in relation to the administration of the cases.
- 75. In case of any and all complaints relating to the processing of personal data the Customer can contact the National Authority for Data Protection and Freedom of Information (1125 Budapest, Szilágyi Erzsébet fasor 22/c, e-mail: ugyfelszolgalat@naih.hu).
- 76. The information relating to the audio recording of the telephone conversation between the customer service and the Customer is contained in the case group 'Audio Recordings Related to Electronic Administration' in the menu item 'About the Police/Data Protection and Data Controller/General Case Groups' on the official website of the Police.

15. Final provisions

77. The Rules and Regulations enter into effect on December 15, 2021, and the Police must make it continuously available for the Clients of the Police on the official website of the Police.
