#### **Submission of the information**

An enterprise with a license or a declaration of use must notify the authorizing authority or the authority issuing the license in writing within 8 days of the setting off of the fireworks and of any unused products. In the case of an activity previously declared the submission of the information can only be made electronically.

In the case of a licensed activity, the information may also be filed electronically.

### **Processing the information**

The information shall be evaluated by the authority issuing the license or certificate.

The authority shall not forward a separate decision to the client of the information notice. If the information contained in the notification is not in accordance with the provisions of the law, license or certificate, the authority shall initiate proceedings or ask the customer to complete the application. The client can fulfill the obligation to submit the addenda by using the RHIP-001 ÁNYK form.
