Procedural order

The form provides for the possibility of filing an appeal electronically against official decisions made in each subject group. Required fields:

- 1) the reference number field (as this information will automatically forward the submission to the competent authority); and
- 2) the case number (which automatically suggests the subject of the appeal).

Topics to submit using the form:

- Decisions on Personal, Property, Private Investigator, and Asset Management System Planning ActivitiesA rendészeti feladatokat ellátó személyek ügyében hozott döntések
- Decisions concerning the notification of pyrotechnic activity
- Decisions taken on the issue of warning and discriminatory alarms
- Decisions on arms licensing procedures

It should be noted that the appeal is against the decision or order of the authority.

Costs and expenses of the procedure:

The appeal shall be subject to the payment of a fee or an administrative service charge. The subject group selected in the form and the subject matter of the appeal will automatically suggest a fee or administrative service fee for the specific case.
