Procedure

Submitting the application

The followings shall be forwarded to the county police headquarters competent in the place of residence of the licensee or to the place of activity of the licensee, in Budapest to the Budapest Police Headquarters:

- a self-defence
- personal and property protection,
- work (category "A" and mufflers),
- film production (category "A"),
- theatrical and traditional firearms (category "A" firearms),
- held in stock by distributors or manufacturers,
- deactivation, surrender or destruction of a weapon in a stockpile licenced for distribution application for.

According to the residence of the licensee or the place of activity of the license, the police headquarters, in Budapest the Budapest Police Headquarters, which must be further changed:

- hunting,
- shooting sports,
- education,
- target practice,
- work,
- film production,
- for theatrical and traditional use,
- deactivation of a firearm in a stockpile licensed for repair, the surrender or destruction of gas and alarm weapons for self-defense without value

The deactivation of firearms must comply with the relevant European Union standard.

Costs and expenses of the procedure

The administrative service fee for a request for the deactivation of a firearm is HUF 2,000 per firearm.

The destruction or worthless delivery of weapons, ammunition (ammunition) is free of charge.

The administrative service fee must be paid to the Budapest Police Headquarters in Budapest using the appropriation utilization framework account of the county police headquarters acting in the case or managing the police headquarters, in advance or in arrears. The administrative service fee can be paid by bank transfer or online credit card payment (VPOS) using the Electronic Payment and Settlement System (EFER). In the case bank transfer, the information field must contain the purpose of the payment e.g. " application for permission to deactivate a firearm" and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

Processing the application

No personal appearance is required for receive the decision.
