#### Submitting an Application

An application for authorization of a domestic transfer of explosives for civil use shall be transmitted to the relevant county police headquarters using the RI-0401 ÁNYK form. If the current form is not forwarded, the form will be deemed not to have been filed, and the customer will be notified by automatic error message by the Police records system.

The contents of the license application and its attachments are defined by the Regulation.

### **Attachments to be added to the application**

- a) the Public Safety Plan of ADR, RID, ADN Chapter 1.10, according to the transport subsection;
- b) certificate that the applicant is authorised to transport explosives, carry out blasting operations or market explosives for civil use.

### **Procedural cost**

The administrative service fee to be paid for the procedure shall be paid to the account number of the police headquarters. The administrative service fee for the procedure is 16,000 HUF, which is payable in all cases. Referring the case number, the Administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS). In the case bank transfer, the information field must contain the registration number returned after the automatic registration, which is a case number consisting of the following positions:

### **Processing an application**

If, during the processing of the application, it is established that the eligible customer has submitted the application in full to the relevant authority and the statutory conditions for authorization are determined, the authority shall decide in a succinct procedure. The electronically authenticated decision shall be issued and sent by the Police to the applying customer. In the course of the procedure, personal appearance is not required.

In the case of an incompletely submitted application there is a possibility to fill in a deficiency, in this procedure there is only a one-time correction of the deficiency. If the customer fails to fill the gap, the authority will either cancel the procedure or reject the application. In the event of termination of the proceedings or rejection of the application, there shall be no refund of the administrative service fee.
