Procedural order

Submitting an application

The notification should be submitted to the Police Headquarter whose jurisdiction covers the activity carried out. In the case of the firearms manufacturer, the firearms distributor as well as for holding the firearms for personal or property protection, for film production purposes (possession of a "A" category), keeping a category A firearm for theatrical and traditional use, and for work (the "A" category firearms and silencers) the notification should be submitted to County Police Headquarters, in Budapest to Budapest Police Headquarters.

Costs and expenses of the procedure

An administrative service fee of application is HUF 3,000.

If the change also justifies the exchange of the issued license (card document), its administrative service fee is HUF 2,000 per card document for the possession of weapons for theatrical and traditional use and for the possession of floating firearms, HUF 9,000 per card document for firearms dealers in case of, HUF 4,000 per card document.

There is no charge for reporting changes to location and contact information.

An administrative service fee should be paid into the appropriation allocation fund account of the county police headquarters governing the local police headquarters proceeding at first instance; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid in advance or ex-prior by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. „changes to organization's data” and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

X X X X X - X X X /X X X/ X X X X. F. (e.g.: 29000-821/111/2019. F.)

No attachment to the application is required.

Processing an application

If the application is submitted to the authority competent for authorization and its content is satisfactory, the authority shall record the change on the basis of the application in a register and where appropriate, issue an electronically certified decision. In the case of change the license (card document) for firearms dealer or change the official certificate (card document) attesting to the existence of a firearms license, the licensee may personally take them through the trading agent from the licensing Police Headquarter during the office opening hours.
