The questions for the exam on weapon knowledge appear in Annex 1, questions relating to home ammunition assembly and reloading appear in Annex 2 of the MoI Decree, while questions for the exam on arms distribution are listed in Annex 10 of the Gov. Decree.

Submitting an application for the exam or for issuing the proof:

The application form for the exam shall be lodged with the county (metropolitan) police headquarters, application for issuing a proof of a successful exam with the county (metropolitan) police headquarters issuing the exam certificate.

The request for issuing a proof is free of charge.

Exam fees:

- Weapon knowledge exam: 10 000 HUF
- Arms distribution exam: 10 000 HUF
- Exam for home ammunition assembly and refilling: 10 000 HUF

Exam fees shall be paid per exam.

The fee shall be paid to the appropriation allocation fund account of the county (metropolitan) police headquarters conducting the examination before appearing for the examination. The fee can be paid by bank transfer or cash transfer order (check). In case of transfer or payment by check, the case number must be indicated in the notification box. The case number will be communicated by the authority in an automatic reply to its location following the electronic submission of form RI-0655. In the case of an application form for an examination submitted on paper (in person or by post), the authority will provide the case number in the notice of the date and place of the examination.

The exam pm the knowledge of weapons, the exam for the distribution of weapons and the exam for home ammunition and reloading may be attended by those who have paid the examination fee and presented, at the place of the examination, the check slip certifying the payment of the examination fee or, in the case of a transfer, the bank statement certifying the completed transaction.

No annex shall be attached to the application form for the exam, or to the application for issuing a proof.

Processing the exam application form or the request:

The county (metropolitan) police headquarters organizing and conducting the exam shall inform the candidate for the examination of the place and date of the examination.

In case of a request for proof of a successful exam, if the client lodged it with the county (metropolitan) police headquarters that issues the exam certificate, the authority sends the

client the electronically authenticated and submitted proof. No personal attendance is required to hand over the proof.
