## **Procedural order**

### **Submitting an application**

The application shall be submitted to the police station, police headquarters or the national police headquarters that issued the licence.

The operator of the vehicle shall notify the licensing authority of the change in the purpose of the vehicle's operation, the withdrawal of the vehicle from circulation and of a change of vehicle operating personnel within 15 days of its occurrence. An operator may request that the licence be revoked within the period of its effectiveness.

### **Costs and expenses of the procedure**

The fee for the application is a general procedural fee of HUF 3,000, - (three thousand)

The fee shall be paid in advance or subsequently by transfer or by using the Internet Bank Card Payment (VPOS) using the Electronic Payment and Settlement System (EFER) to the account number of the county (metropolitan) Police Headquarters or the National Police Headquarters in accordance with whichever holds jurisdiction for the proceedings in the first instance.

1. Account number: listed at the end of this Information.
2. Advance payment: In the section of the reference, the word "bejelentés" and the name of the entity performing the activity shall be indicated.
3. Subsequent payment: At the latest on the day following the date on which the proceedings are registered with the authority. In the reference section of the transfer, the filing number of the case shall be indicated. (Filing number: RZSEIR registration number indicated by the police records system in the notice of the applicant's Customer Gateway storage space)

### **Processing an application**

The authority responsible for the proceedings shall decide on the comprehensive procedure within 8 days of the receipt of the application. The electronically authenticated decision shall be issued and sent by the Police to the applying customer. During the processing no personal appearance is required.
