Lodging the request:

In case of firearms for self-defence, the notification on change shall be lodged with the county police headquarters competent by the home address of the licence holder or, in the absence thereof, the place of storing the firearm, with the Budapest Metropolitan Police Headquarters in Budapest,

in case of keeping firearms for hunting, sports, target practice or employment purposes and in case of home ammunition assembly: with the police station competent by the home address of the licence holder or, in the absence thereof, the place of storing the firearm, with the Budapest Metropolitan Police Headquarters in Budapest,

in case of using museum weapons for sports purposes: with the police station competent by the home address of the licence holder or the Budapest Metropolitan Police Headquarters in Budapest,

in case of using a muzzle-loading firearms for hunting purposes: with the police station competent by the home address of the licence holder or, in the absence thereof, the place of storing the ammunition parts, with the Budapest Metropolitan Police Headquarters in Budapest.

Administrative fees:

- Notification on name change (in case of firearms licence) 400 HUF.
- Notification on the change of home address or weapons storage place (in case of firearms licence) 3000 HUF.
- Notification on name change (in case of keeping a Flobert firearms or carrying a gas gun or blank firing gun) 2000 HUF per document.
- Notification on name change or/and change of home address or/and change in the place of storage of ammunition parts (in case of using a muzzle-loading firearms for hunting purposes) 6000 HUF.
- Notification on name change or/and change in the place of storage of ammunition parts (in case of using a museum gun for sports purposes) 2000 HUF.
- Notification on name change (in case of a licence for home ammunition assembly) $10\,000\,\mathrm{HUF}.$
- Notification on the change in the place of storage of ammunition parts (in case of a licence for home ammunition assembly), on the change of nationality, personal identification number or employer data are free of charge.

Administration service fees shall be paid to the appropriation allocation fund account county police headquarters directing the police station proceeding on first instance or the Budapest Metropolitan Police Headquarters in Budapest with advance or deferred payment. The administration service fee can be paid by bank transfer or internet-based card payment (VPOS) using the Electronic Payment and Clearing System (EFER). In case of bank transfer, the reason for payment shall appear in the comments section as "request for homemade ammunition assembly and reloading", just like the registration number of the case, if known. The registration number is structured as follows:
