#### Submitting an application

An application for revocation of an ID pass and a badge shall be submitted by a representative of the employer of the person performing the activity to the police headquarters of the county (metropolitan) which has jurisdiction and competence.

The employer must hand over the identity card and badge enclosed with the application to the county (capital) police headquarters which issued it, by mail or at the customer reception hours.

The procedure is free of charge.

### **Processing an application**

The requested application will be examined by the authority. If, during the processing of the application, it is established that the application has been submitted by the authorized representative of the employer (organization, company) to the relevant and competent authority in full (or in compliance with the call for a corrective action), the authority shall take a decision which it sends to the client and it also arranges for the withdrawal of the ID pass and badge in the register.

The decisions are electronically authenticated and issued documents.
