## Submitting an application

An application for the authorization of intra-community transport of explosives for civil use shall be submitted to the National Police Headquarters.

The contents of the license application and its attachments are defined by the Regulation.

## Attachments to be added to the application

- a) the Public Safety plan in compliance with the transport subsection, Chapter 1.10 of ADR, RID, AND
- b) a copy of the authorization of the host state and the authority of the neighbouring state to the place of exit.

## **Procedural cost**

The administrative service fee to be paid for the procedure shall be paid to the account number of the National Police headquarters. Account numbers listed in table 1. of information contained on next link: <u>az űrlapbenyújtáshoz kapcsolódó fizetési kötelezettségek teljesítéséhez</u>

The administrative service fee for the procedure is 34,000 HUF, which is payable in all cases. Referring the case number, the Administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the registration number returned after the automatic registration, which is a case number consisting of the following positions:

### **Processing an application**

If, during the processing of the application, it is established that the eligible customer has submitted the application in full to the relevant authority and the statutory conditions for authorization are determined, the authority shall decide within the general administrative deadline. The electronically authenticated decision shall be issued and sent by the Police to the applying customer. In the course of the procedure, personal appearance is required to accept the security document that is attached to the decision, unless the client requests it to be sent by post.
